

Care Transitions Initiative



Each year, nearly one in five Medicare patients is readmitted to the hospital within 30 days of discharge. Many of these readmissions are preventable and needlessly affect patients' quality of life, as well as burden our health care delivery system. By standardizing the provision of care to patients within and across care settings, and engaging patients and their families as active care partners, it is possible to reduce unnecessary hospital readmissions.

Over five years ago, Qualidigm and the Connecticut Hospital Association (CHA) launched a two-pronged Heart Failure Readmission Initiative to decrease preventable hospital readmissions for patients with heart failure.

CHA led the collaborative quality improvement activities with 24 participating hospitals. Qualidigm developed, convened and facilitated the complementary "Communities of Care" initiative. A "Community of Care" includes a hospital(s) and their nursing facilities, home health agencies, physicians, and community-based organizations with which they share patients. Under Qualidigm's leadership, 15 volunteer "Communities" were formed to improve transitions between settings of care.

In 2012, this collaboration was renamed the Care Transitions Initiative and broadened to address preventable hospitalizations of all patients across Connecticut.

Qualidigm has continued to support existing and new communities with education and technical assistance on evidence-based quality improvement strategies in both one-on-one and group settings. Highlighted strategies include:

- use of data to identify opportunities for improvement
- enhanced communication between care settings
- timely post hospitalization physician visits
- standardized patient/family education
- emergency care plans
- medication reconciliation
- palliative and hospice care
- post-acute care planning
- emphasis on social determinants of health
- adverse drug events

The strategies that are chosen are based on the specific needs of each community. Best practices are shared via a series of linked, interactive workshops, intervening phone calls, and online resources.
